Reservations, Deposit and Final Payment

- A deposit is due at the time of reservation. No rooms or flights are held until a deposit is received.
- Deposit and selection of a payment is required along with a completed registration packet for all new reservations.



- Clients must adhere to the selected payment plan, with first payment due not less than 30 days after payment of the deposit. **A missed payment will result in cancellation of room reservation and previous payments will not be refunded.**
- It is your responsibility to ensure that your travel roommate is also making their monthly payments. If your roommate cancels your reservation rate may be subject to increase and you are responsible to pay increased rate.
- Please notify us immediately via email or text if you are having trouble making the payments, so we will not cancel your reservation and find the appropriate solution.
- Please be sure you will be able to commit to the travel event prior to making deposit.
- Due to tour, vendor, and hotel contracts all payments to Amazing Journey Cultural Group Tours: Exotic Destinations, LLC are non-refundable and non-transferable.
- All final payment dates are clearly noted in your registration packets. It is your responsibility to be sure payments are made on or prior to due date. If you fail to make your final payment by the final payment date, your reservation will automatically cancel and all previous deposits and payments will be forfeited.
- All late payment request must be submitted in writing via email with the intended date of payment.

Method of Payment

- Credit / Debit are our **only** method of payment and must be accompanied with credit card authorization form.



- The Credit Authorization is good for the duration of trip payment and for credit number provided.
- A copy of the credit card front and back and a copy of passport must accompany the credit card authorization form. New credit authorization form

and a copy of the credit card (front and back) is needed as soon as possible if there is a switch in credit cards during the trip payment plan. It is your responsibility to notify us of any credit card changes.

- Email must be sent every month of the date to withdraw funds for the trip, unless otherwise specified. If your card is declined, we will attempt to charge your card 2 days later. After 3 unsuccessful attempts your trip (and automatic billing) will be canceled.

Other Terms

- Cultural Group Tours: Exotic Destinations, LLC has the right to decline or exclude services to anyone participants or registering participants of the tours.
- Cultural Group Tours: Exotic Destinations, LLC has the right to change and/or substitute any itinerary, excursions, and /or events of its escorted

tours for any reason or if condition warrants which may include unavailability, comfort, safety, or any other convenience.

- If a tour is cancelled, it will be settled by full reimbursement of all monies paid to the tour company by the tour participants, planning & research fees are excluded and are non refundable and/or non transferable.



- The American Disabilities Act is only applicable in the USA and is limited outside the USA border. It is your responsibility to review the tour to assess if it fits your physical ability. No tour will be modified to fit one's physical ability.
